Privacy Policy – Hineni

This Privacy Policy governs the manner in which Hineni Youth and Welfare - Australia Inc. (“Hineni”) collects, uses, maintains and discloses information collected from its participants, and users of its website. This privacy policy applies to the website and all products and services offered by Hineni.

What Personal Information we Collect

- When a participant or parent/guardian expresses interest in Hineni’s events and activities, we may collect their contact details, such as their name, email address and phone number.
- When a participant signs up for a Hineni camp, seminar or Israel program, we collect a variety of information, including their name, mailing address, email address, phone number, contact preferences, medical details and banking details.
- When a camp participant requests financial assistance, we may additionally collect a variety of specific financial information such as employment status and financial situation.
- When a Shnat program participant requests financial assistance, we may additionally collect a variety of specific financial information, such as income, expenditure, assets, employment status and dependents.
- We may also take photographs of our participants, leaders and other attendees at our activities, events, camps and Shnat programs.

How we Use your Personal Information

- The personal information we collect allows us to keep you informed about Hineni's activities, events, camps and Shnat programs. If you no longer wish to be contacted by Hineni, you can unsubscribe from our mailing list, or indicate to a Hineni leader that you no longer wish to be contacted.
- Your personal information also enables us to respond to your queries and requests more efficiently.
- Your personal information will be used to contact you about the logistical details of any seminar, camp or program you have registered for. In the event that an issue arises during any Hineni activity concerning the participant, the contact details of the participant's parent/guardian may be used to inform the parent/guardian of the incident and gain their input in dealing with the incident.
- The medical details of the participant are used to provide them with adequate medical care during Hineni camps, seminars and programs. The participant's medical details may be passed on to a medical professional in the event that the participant needs professional medical treatment while in Hineni's care.
- We may use banking details to identify where a payment has originated from, and to provide reimbursements if necessary.
- We may use your specific financial information to assess your suitability for financial assistance.
- We may use photographs taken of you for promotional purposes or for display on any official medium of Hineni. Signing an Indemnity Form in a particular year indicates that you consent to Hineni using any photograph taken in that year for the purposes outlined above, for an indefinite period of time.
